2024 HALLOF FAME DISTINGUISHED SERVICE

- Objective** To honor individuals who have shown exceptional dedication and outstanding service to the credit union movement in the Dakotas through a lifetime of contributions.
- Method** Recipients may be selected based upon the criteria relating to credit union chapter, Association, national, volunteer, and community activities. Due to the criteria and qualifications process, the Hall of Fame Distinguished Service Award may not be presented every year. Nominations may be submitted by any credit union, board, Chapter or the Dakota Credit Union Association (DakCU) and Mid-America Service Corporation (MASC) by completing a nomination form and personal data form and returning it by the deadline. Nominations can also be made posthumously.
- Recognition** Induction into the Hall of Fame Distinguished Service will take place at the Annual Summit with inductees being confidentially announced prior to the convention. Inductees will receive a personalized commemorative plaque in their honor. Each inductee's name will also be displayed on the Credit Union Hall of Fame Distinguished Service wall, located in the DakCU office.
- Eligibility** Any person who has given paid or volunteer service to the credit union movement is eligible. Association and committee chairs and presidents/CEOs are eligible. Persons who were candidates in the past are eligible for renomination. Employees of the Association and MASC are not eligible to participate in this program while employed by MASC/DakCU.
- Criteria** Nominees for the DakCU Hall of Fame Distinguished Service Award must meet the following criteria:
- Be a credit union employee or volunteer in the process of retiring within one year's time or have been retired no more than three years prior. Nominees must be member of a DakCU affiliated credit union.
 - Selflessly given exceptional time, effort, and talent to the betterment of the credit union movement.
 - Served, assisted, or been involved in the credit union movement for more than 10 years.
 - Be in good standing in the community.
 - Understand and personify the credit union philosophy of "People Helping People," promote the credit union idea, and actively demonstrate loyalty to the entire organized credit union movement.
 - Demonstrated organizational leadership, high professional standards, made volunteer contributions to the movement, and promoted technical innovations in the credit union service.
 - Nominee must have a simple majority of those directors present and voting to be inducted into the Hall of Fame Distinguished Service.
- Exceptions**
- Person may be nominated if death occurs while working as a credit union professional.
 - Person may be nominated if credit union professional has 25 years or more of service.
 - Other exceptions to these criteria can be made upon unanimous approval by the Association Board.
